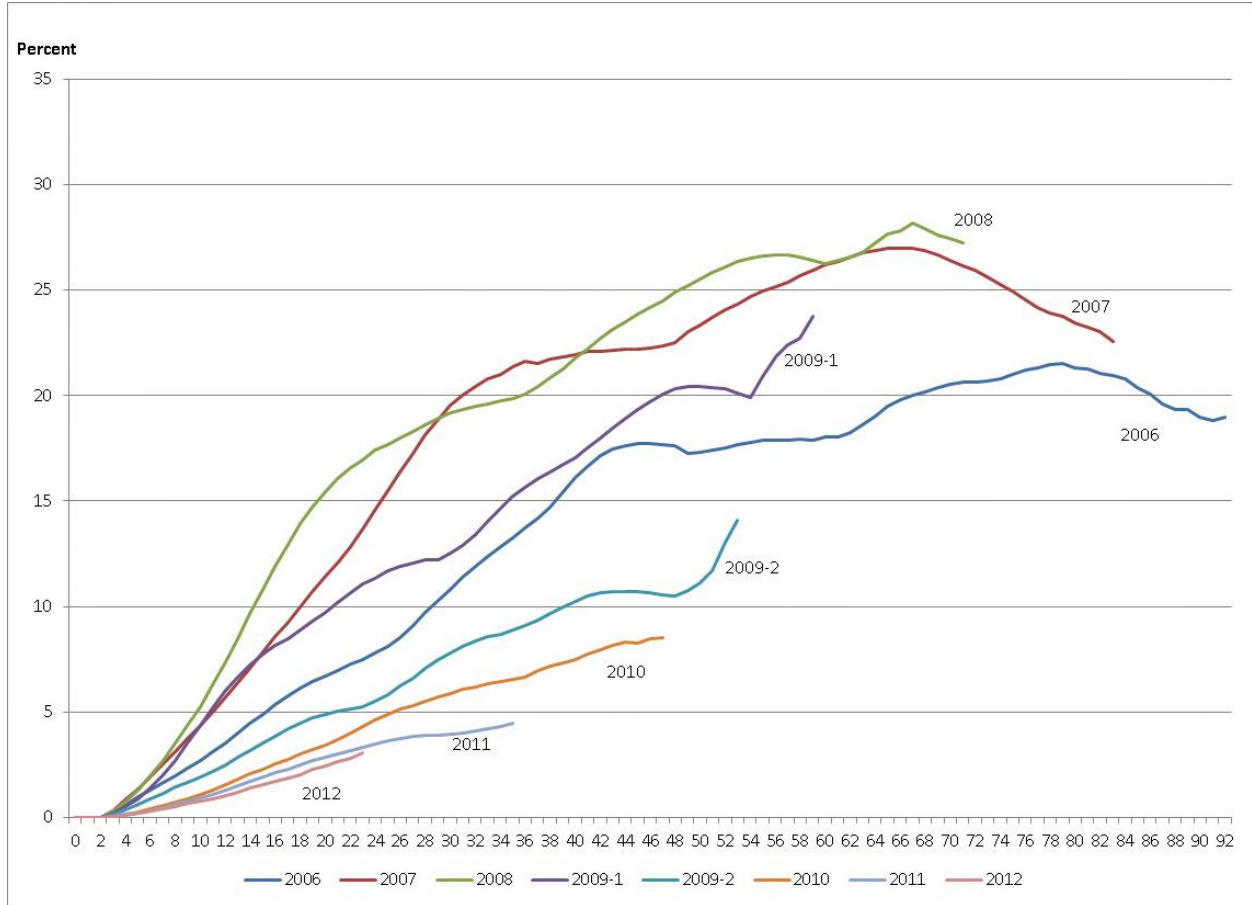

Figure 1: Seriously Delinquent Vintage Rate Curves by Fiscal Year (All Loans)

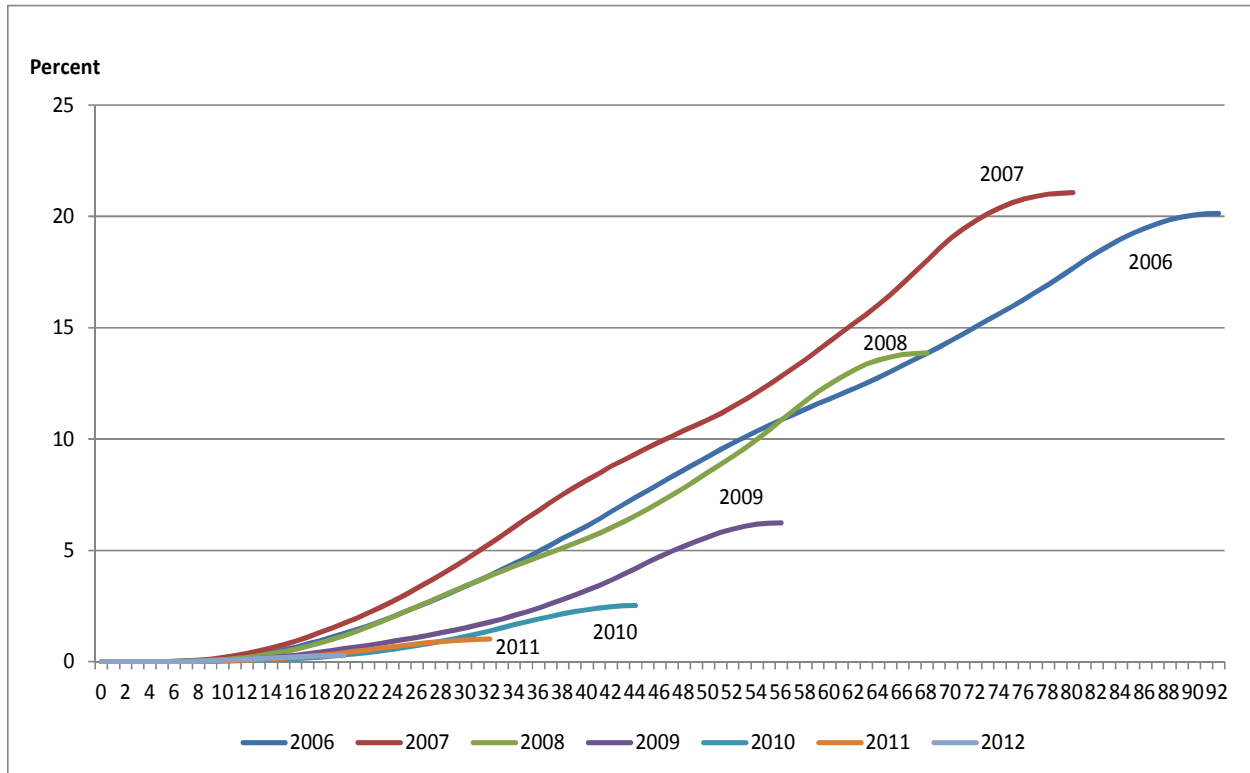
FY 2009 Breakdown in to 6-Month Periods^a
