

SUBJECT: January 2011 Cancellation for Materials Releases and
Structural Engineering Bulletins

The Office of Manufactured Housing Programs assists FHA by issuing product acceptances of new building materials, products and systems to be used in houses and buildings financed with FHA-insured mortgages, including single family homes, multi-family housing, and health care type facilities. These product acceptances, known as Materials Release Bulletins (MRs) and Structural Engineering Bulletins (SEBs), are issued under FHA's Technical Suitability of Products (TSP) program.

Periodically, the FHA Standards Program cancels product approvals due to inactivity by the sponsor or because the sponsor is no longer producing the product or system in which the bulletin was originally obtained. This memo provides you the most recent list of product approvals the FHA Standards Program has cancelled as of January 25, 2011. This is a list of 14 Materials Releases and 14 Structural Engineering Bulletins that are cancelled.
