The Department of Housing and Urban Development (HUD) will host a special Webinar overview briefing session on **December 18, 2013 at 1:00 PM Eastern** to review with FHA stakeholders the details of HUD's Qualified Mortgage Final Rule. This Final Rule was published in the Federal Register on December 11, 2013.
