# **LEAP Transition Update**

FHA is entering the final phases of implementation for the release of the Lender Electronic Assessment Portal (LEAP). On May 9, 2014, LEAP will replace the Lender Assessment Sub-System (LASS) and the "Lender Approval" and "Cash Flow Account Setup" sections of FHA Connection. Due to the transition to LEAP, these sections of FHA Connection will be inaccessible starting April 18, 2014.
