Federal Housing Administration (FHA) Mortgagee Review Board: Administrative Actions Posted Today in *Federal Register*

Today, FHA published all completed administrative actions taken by the Mortgagee Review Board during the period from October 1, 2012 to September 19, 2013. The *Federal Register* Notice (Docket No. FR-5802-N-01) identifies 21 fact-based cases and 25 mortgagee recertification violations.
