### Federal Housing Administration (FHA) Mortgagee Review Board: Administrative Actions Posted in *Federal Register*

Today, the FHA published all completed administrative actions taken by the Mortgagee Review Board during the period from October 1, 2013 to September 30, 2014. The *Federal Register* Notice (Docket No. FR-5864-N-01) identifies the cause, and provides a description, of the administrative actions taken by HUD's Mortgagee Review Board against HUD mortgagees in 17 fact-based cases and 79 mortgagee recertification violations.
