"A Live Dialogue" Single Family Housing Policy Handbook Forum Coming to Chicago June 23, 2015

The Federal Housing Administration's (FHA) first broad-based, in-person "A Live and In-Person Dialogue – The Single Family Housing Policy Handbook In-Depth" forum is coming to Chicago on June 23, 2015. If you are an FHA-approved mortgagee or other stakeholder in FHA transactions, this is your opportunity to hear first-hand from FHA Office of Single Family Housing staff about the *Single Family Housing Policy Handbook*—including its structure, content, and key policy changes that become effective on September 14, 2015.

- Others with detailed knowledge of FHA Single Family Housing policy and requirements
