FHA Publishes *Federal Register* Notices Soliciting Public Comments on “Loan-Level” and “Lender-Level” Certifications

Today, the Federal Housing Administration (FHA) published two notices in the *Federal Register* soliciting public comment on proposed information collection for its “loan-level” and “lender-level” certifications. The two notices are:

- 30-Day Notice of Proposed Information Collection (“loan-level”): *Application for FHA Insured Mortgages (Form HUD-92900-A)*, Docket No. [FR-5831-N-39](#). This notice is being issued in response to public comments received on the notice issued May 15, 2015.
- 60-Day Notice of Proposed Information Collection (“lender-level”): *FHA Lender Approval, Annual Renewal, Periodic Updates, and Required Reports by FHA-Approved Lenders*, Docket No. [FR-5835-N-12](#).
