Mortgagee Review Board Administrative Actions Notice Published in the *Federal Register*

Today, the Federal Housing Administration (FHA) published a notice in the *Federal Register* ([FR-5948-N-01](#)) of all completed administrative actions taken by the Department of Housing and Urban Development's (HUD) Mortgagee Review Board during the period from October 1, 2014 through September 30, 2015. The notice provides a description of, and the cause for, the Mortgagee Review Board's administrative actions against HUD mortgagees in 14 fact-based cases and 48 mortgagee annual recertification violations.

Update for the 203k Calculator

On May 10, 2016, the Federal Housing Administration (FHA) implemented a JavaScript update for the 203k Calculator function in FHA Connection (FHAC) and available online via [HUD.gov](#). Depending on how their Internet browser is configured, some users may need to clear their Internet browser's cache in order for the changes to take effect.

To clear cache in Internet Explorer:

1. Click the gear icon in the upper right corner and select "Internet Options."
2. From the Internet Options dialog box click the "Delete..." button in the "Browsing history" section of the "General" tab.
3. Ensure "Temporary Internet files and website files" is selected and click "Delete."
