Description: This free, one-day, in person, instructor-led training course will cover FHA appraisal requirements, including FHA appraisal protocol and updates to FHA appraisal policy. This course is ideal for seasoned FHA appraisers, appraisers new to the FHA Appraiser Roster, as well as those working toward appraiser licensing. Although intended primarily for appraisers, other industry professionals, including underwriters and processors, may benefit from attending.

This training course is approved by California's Bureau of Real Estate Appraisers (BRE) for seven hours of Continuing Education Units/Credits (CEUs) for CA licensed appraisers. For non-CA licensees, please contact your state's licensing board for credit eligibility. To be eligible, you must attend the **entire** seven-hour presentation.

Special Instructions: **Advance registration is required**, as seating is limited and available on a first come, first served basis. Walk-ins are welcome but will not be guaranteed admittance. Onsite registration is from 8:00 AM to 8:30 AM.

This is a government facility. Please be advised that the onsite security screening process is similar to an airport security screening. Attendees must provide a valid, government-issued photo I.D. and course registration confirmation at the guard station. Please allow extra time to go through the security screening process.
