Mortgagee Review Board Administrative Actions Notice Published in *Federal Register*

Today, the Federal Housing Administration (FHA) published a notice ([Docket No. FR-6025-N-01](#)) in the *Federal Register* of all completed administrative actions taken by the Department of Housing and Urban Development's (HUD) Mortgagee Review Board during the period from October 1, 2015 through September 30, 2016. The notice provides a description of, and the cause for, the Mortgagee Review Board's administrative actions against HUD mortgagees in 25 fact-based cases and 253 annual recertification violations.
