Improved Lender List Search Launched Today

Today, the Federal Housing Administration (FHA) launched an improved lender list search capability from a new [HUD Lender List Search](#) web page on HUD.gov. From this page, the public can search for HUD-approved Single Family and/or Multifamily lenders, using a variety of criteria, including:

- Lender Name
- City and State
- Mortgage Originator and/or Mortgage Servicer
- Home Equity Conversion Mortgage Program Lenders
- 203(k) Rehabilitation Mortgage Insurance Program Lenders

The new HUD Lender List Search page replaces the previous Lender List lookup page on HUD.gov. While search criteria have not changed, users will notice improved performance and quicker response times when using the new search capability.

Users with bookmarks to the previous Lender List lookup page will be automatically redirected to the new page, beginning today. Frequent users of the Lender List search should bookmark the URL for the new page, https://portal.hud.gov/hudportal/HUD?src=/program_offices/housing/sfh/lender/lenderlist.
