1.2 Term of Contract: Obligation to Operate Project for Full Term.

- (a) Term of Contract. The initial term of this Contract for any unit shall be 20 years, beginning with the effective date of this Contract for such ECHO unit, commitments to extend expiring contracts during the year prior to the date of expiration. If the project is completed in stages, the term shall be separately related to the ECHO units in each stage. However, the total Contract term for all the stages, beginning with the effective date of the Contract for the first stage, shall not exceed 22 years.
- (b) Obligation to Operate Project for Full Term. The Owner agrees to continue operation of the project in accordance with this Contract for the full term specified in paragraph (a).
- 1.3 HUD Assurance. The execution of this Contract by HUD is an assurance by HUD to the Owner that:
 - (a) The faith of the United States is solemnly pledged to the payment of project rental assistance payments pursuant to this Contract, and
 - (b) HUD has obligated funds for these payments.
