Previously, the Assistance Contract List displayed the contract data, but the detail and status pages were blank. The problem was a contract with two different Participant IDs under one contract and the same DUNS number.

iREMS has modified the stored procedure AM_GET_LOOK_UP_SPECIFIC_CNTRCT' that brings back the DUNS for a particular contract on the status detail page to only group by the contract number.

Previously, within *Contract Processing*, in an auto OCAF generated renewal, when the user set and saved the '*Renewed Utility Allowance*', and sent the Owner the Letter for signature, and when the letter was received back the user set the '*Rents Final for Contract Exhibit*' to Yes, and hit the save button to finalize the process - the *Utility Allowance* amounts reverted back to their old values. This was not correct. The *Utility Allowance* amounts need to remain at the value they were set at when the Letter to Owner was generated.

The logic has been fixed within the *Contract Processing* sub-function of iREMS so that the old *Utility Allowance* values do not re-populate once the user set the '*Rents Final for Contract Exhibit*' to Yes and hit **Save** to finalize the process.
