CFPB Interim Final Rule Published:

On October 23, 2013 the Consumer Financial Protection Bureau (CFPB) published an Interim Final Rule affecting Housing Counseling. This rule amends provisions in Regulation Z and final rules issued by the CFPB in 2013, which, among other things, required that consumers receive counseling before obtaining high-cost mortgages and that servicers provide periodic account statements and rate adjustment notices to mortgage borrowers, as well as engage in early intervention when borrowers become delinquent.
