Revised LOCCS Form:

Effective immediately for those housing counseling agencies that received HUD grants and have access to the Line of Credit Control System (LOCCS)/Voice Response System (VRS) payment system, the form to obtain access to LOCCS system has been revised. LOCCS system is the system HUD uses to disburse and track the payment of grant funds to Grant recipients (i.e. grantees). Form HUD-27054 LOCCS VRS Access Authorization Form dated 11/2013 will be used. The previous edition of this form which was dated 08/2011 expired on 8-31-2013 and is now obsolete. The 8/2011 version of the form was removed from HUD.GOV and HUDClips. When using the new form to obtain access for a new user, reinstate a user or other functions as noted on the form in Section 1: please ensure you mail the original form to the HUD Program Office for review. For the Comprehensive Housing Counseling Program (CHC) grantees please send your form to HUD's Program Office in the Office of Housing Counseling (OHC) who will sign Section 9 of the form (Program Office Point of Contact's Name). The Program Office Point of Contact will then send the original form to HUD's Chief Financial Officer in Washington, D. C. for processing. Housing Counseling Program New Certification Requirements: The Housing Counseling Program proposed rule, Housing Counseling Program: New Certification Requirements was published in the Federal Register on Friday, September 13, 2013. The proposed rule makes changes to HUD's Housing Counseling Program that were required by the Dodd-Frank Act enacted into law on July 21, 2010. It describes new certification requirements for the Housing Counseling Program as well as other important changes, and invites interested persons to submit comments about the proposed rule.

FHA Mortgagee Letter 2013-26 - Back to Work: As part of an ongoing effort to expand access to mortgage credit for families impacted by the recent financial crisis, FHA is providing guidance for underwriting borrowers credit who, but for economic circumstances brought on by the crisis, would be creditworthy. These policy announcements provide greater clarity and flexibility to lenders encouraging them to consider additional factors when evaluating a borrower's credit, ultimately supporting the recovery of the housing market and the economy. All applicants for this program must complete pre-purchase counseling from a HUD-approved housing counseling agency at least 30 days prior to submitting their application for a loan. During this call we discussed housing counseling requirements for this program.

Additionally, HUD's Office of Housing Counseling presenters fielded questions from the audience and provided responses.
