Expanded Permissive Loss Mitigation for Home Equity Conversion Mortgages (HECMs) and Mortgagee's Optional Extension to Submitting a Due and Payable Request

Today, the Federal Housing Administration (FHA) published <u>Mortgagee Letter 2016-07</u>: *Expanded Permissive Loss Mitigation for Home Equity Conversion Mortgages (HECMs) and Mortgagee's Optional Extension to Submitting a Due and Payable Request*. The ML provides mortgagees with an optional extension when submitting a due and payable request where borrowers are behind on the payment of their property taxes and/or hazard insurance premium by less than \$2,000.

Additionally, the ML permits mortgagees to cure a borrower's taxes and/or insurance default so long as no cost is passed along to HUD and the mortgagee agrees to not seek loan assignment for at least a period of 3 years. It also removes a previous restriction prohibiting the use of the permissive loss mitigation options announced in <u>ML 2015-11</u> for borrowers in foreclosure at the time of issuance of that mortgagee letter.
